EMD in the form of Demand Draft/ Pay Order/FDR/Bank Guarantee should be valid for 3 months which can be, if required, further renewed for 3 months. The EMD is payable by all categories of tenderers and no exemption is permissible . EMD in the form of cheque/cash will not be acceptable. However, copy of the aforesaid EMD may be uploaded alongwith the technical bid.	6.1 Tenderer must submit an EMD of ₹ 2,00,000/- (Rupees Two Lakhs Only) in favour of Director, VPCI in the Vallabhbhai Patel Chest Institute, University of Delhi, Delhi before the closing date i.e 12.11.2018 upto 01:00 P.M. of bid submission.
