### TERMS & CONDITIONS:-

1. The prices shall be quoted in Indian Rupees only.
2. The total Prices shall be for the complete scope as per technical specifications, inclusive of all taxes & duties, insurance, packing & forwarding charges, any other incidental charges etc.
3. Xerox of the MOUs with previous colleges must be attached. (at least 3)
4. If the selected party Tenderer is found to be fake, then the College has the right to forfeit EMD.
5. Cost should be provided in the end of each section separately for all the items.
6. Note-(\*) this indicates that the quantity may change.

### GENERAL TERMS & CONDITIONS:-

1. The work shall be done as per specifications.
2. Quoted rate should be inclusive of all taxes/levies including GST, payable under respective states. Bharati College will not entertain any claim, whatsoever in this regard.
3. No transport will be paid by the College.
4. College reserves the right to accept or reject any tender without assigning any reason.
5. Conditional Tender will not be accepted.
6. Necessary statutory deductions as applicable will be deduction at source.
7. Security Deposit will be deducted from the tender amount.
8. Nothing extra will be paid to the agency by the College.
9. Debarred agency/or individual shall not be permitted to participate in the tendering process. Agency should be reputed and should not have a tarnished reputation.
10. Any individual who has been debarred is not permitted to take part in any negotiations or represent an agency even if he holds a power of attorney on behalf of the agency. Any agency engaging debarred persons is also liable to be debarred.
11. If the entire work is not done within the stipulated time mentioned in work order, it will be the sole discretion of the Principal, Bharati College to accept the work of the particular item on such terms as the Principal deems fit and proper or to cancel the supply order/to stop any payment against the work/to **forfeit the Earnest Money** or to debar the concerned agency. The decision of the Competent Authority shall be final and not be called in question before any Forum.
12. If any vendors submit a faulty or incomplete tender, for the first time the tenderer shall not be allowed to participate in future tendering.
13. In case the rates quoted by the bidders are same, then in order to arrive at a decision, a draw of lots shall be carried out by a Committee comprising of the College.
