

3. This tender document is not transferable. The tendered work, if awarded, is not transferable.
4. The successful tender has to submit a Performance Guarantee amount equal to 5% of quoted amount in the form of Demand Draft/FDR in favor of "Director – V.P. Chest Institute". The performance guarantee will be released after submission of completion certificate of work.
