2. The Tender shall remain open for acceptance for one hundred and twenty (120) days from the date of opening of tenders by the Vallabhbhai Patel Chest Institute (VPCI). The time limit for acceptance may be extended by VPCI at its discretion for such further period, as it may notify.

3. The work awarded to the agency is liable to complete work within the time period, awarded work is not transferable to any third party/agency.
4. The final quantity for Item 1 to 37 (of financial BOQ), will be as per as requirement and actual basis.
5. The Tender Fee and EMD is accepted in the form of FDR/DD/Bank Guarantee/Banker's Cheque from any of the Commercial Banks, in favour of "Director VPCI". The Tender Fee and EMD should be deposited in person in the office of JOINT REGISTRAR, 3rd Floor, Multistory Building, VPCI, in a closed envelope by super subscribing "Tender Fee and EMD in r/o Rate contract for Supplying of spare parts/servicing Materials for 489 air conditioners (split/window/vertical and cassette) installed in VPCI, (Under two bid system)." (clearly indicating the name and address of tenderer on backside by whom the same is submitted) Latest by the last date of bid submission. Failing which offer will be liable for rejection. However, Bidder, have to attach scanned copies of proof of payment towards tender fee and EMD along with their e-tender (with Technical bid) at Annexure - D.
6. The successful tender are required to submit a Performance Guarantee amount equal to 10% of the quoted amount in the form of Demand Draft/FDR in favour of "Director – V.P. Chest Institute" for a validity of sixty days beyond the date of completion of all work. The performance guarantee will be released after submission of completion certificate of work/contract.
7. The site may be inspected in all working days (Monday to Friday 10 A.M. to 4 P.M. except holidays).
8. VPCI reserve the right to accept or reject any or all the tenders without assigning any reason.
9. The incomplete tenders are liable to be rejected without assigning any reason.
- 10. The Tenderers should carefully calculate and mention the cost of items and GST value thereon in the appropriate column of financial bid BOQ.**
- 11. In case, the quoted price has wrong calculations, the liability, if any, will be borne by the tenderers and no escalation in the final amount will be paid by VPCI.**
12. The Contract may be valid for a period of one year from the date of award of work order and may be extended for the quarterly/half yearly/yearly based on the requirement and satisfactory performance of the agency.
13. The Items/parts vise lowest amount will be considered as L1.
14. CPWD norms will be followed.
15. Manual bids shall not be accepted.
