Terms & Conditions for Purchase of Mathematica

1. The firm must be carrying a certificate by the authorized distributor/reseller to supply, install and provide support for the software.
2. The bidder should have capability to supply the software and successfully supplied and installed Mathematica software in at least 2 Government academic Organization/Institute. This should be duly supported by the Purchase Order/Work Order copies.
3. All the distributors/channel partners & Resellers of an OEM as well as partner/reseller of a Distributor can participate in this tender with a valid Authorization letter/ Agreement copy from the OEM or the Distributor to be enclosed.
4. The bidder should not be currently blacklisted or have been blacklisted with any Government of India Agency/PSU, any State Government department. The bidder shall furnish a written declaration in this regard on the letter head of the firm.
5. The firm should submit attached copy of TIN number and PAN number in bid; failing which their offer will not be considered.
6. At least 2 days of in house Classroom training to be provided at Kamala Nehru College (University of Delhi), August Kranti Marg, New Delhi-110049.
7. On Site installation should be provided installation, configuration and successful working of the software should be ensured.
