2. The Tender shall remain open for acceptance for one hundred and twenty (120) days from the date of opening of tenders by the Vallabhbhai Patel Chest Institute (VPCI). The time limit for acceptance may be extended by VPCI at its discretion for such further period, as it may be notified.
3. The work awarded to the agency is liable to complete work within the time period, awarded work is not transferable to any third party/agency.
4. The Tender Fee and EMD are accepted in the form of FDR/DD/Bank Guarantee/Banker's Cheque from any of the Commercial Banks, in favour of "Director VPCI". The Tender Fee and EMD should be deposited in person in the office of JOINT REGISTRAR, 3rd Floor, Multistorey Building, VPCI, in a closed envelope by super subscribing "Tender Fee and EMD in r/o Annual Maintenance Contract (AMC) of 2 Numbers 500 Kva and 1 number 62.5 Kva Kirloskar make D.G. sets installed at Gate No. 1 and near Radiology department (VCH) of VPCI, (Under two bid system)." (clearly indicating the name and address of tenderer on the backside by whom the same is submitted) Latest by the last date of bid submission. Failing which offer will be liable for rejection. However, Bidder, have to attach scanned copies of proof of payment towards tender fee and EMD along with their e-tender (with Technical bid) at Annexure - D.
5. The successful tenderer is required to submit a Performance Guarantee amount equal to 5% of the quoted amount in the form of Demand Draft/FDR in favour of "Director - V.P. Chest Institute" for the validity of sixty days beyond the date of completion of all work. The performance guarantee will be released after submission of completion certificate of work/contract.
6. The site may be inspected in all working days (Monday to Friday 10 A.M. to 4 P.M. except holidays).
7. VPCI reserve the right to accept or reject any or all the tenders without assigning any reason.
8. The incomplete tenders are liable to be rejected without assigning any reason.
9. **The Tenderers should carefully calculate and mention the cost of items and GST value thereon in the appropriate column of financial bid BOQ.**
10. **In case, the quoted price has wrong calculations, the liability, if any, will be borne by the tenderers and no escalation in the final amount will be paid by VPCI.**
11. The AMC may be valid for a period of one year from the date of award of the work order and may be extended for the quarterly/half yearly/yearly based on the requirement and satisfactory performance of the agency.
12. The overall lowest amount will be considered as L1.
13. CPWD norms will be followed.
14. Manual bids shall not be accepted.
